	The objective of the program is to acquaint applicants with the most important linguistics, literature and translation schools and approaches, with the topical issues and problems of modern philology, to supply them with knowledge required in linguistics, literature, and translation theories, to improve their skills in philological activities. An applicant is to critically estimate: scientific theories and methods of investigation in linguistics, literature studies, and translation studies. Theoretical courses aim at teaching the applicants to critically estimate the basic theoretical issues in linguistics, literature and translation sciences, with due regard to their historical past and current state (General Linguistics, Contrastive and Typological Linguistics, National Literature, History of Foreign Literature, Theory of Aspect Translation). Practical classes are assigned to adapt the theoretical courses’ principles.
