II. Higher Education Candidates Certification Forms

Final certification is based on the assessment of learning outcomes and levels of competence applicants.

Certification candidates of a qualifying level "Bachelor" and specialty 073 "Management" takes the form of public performance and qualification of certifying exam.

During certification applicants of qualification level "Bachelor" and of specialty 073 "Management" implement and defense a qualification work in public. Qualifying work is performed in accordance with the directions of scientific and applied research and must certify the applicant's level of training. Qualifying work must contain the results of their theoretical research, analysis of enterprise's economic activity and provide for the development of new methods in enterprise's activity.

Qualifying work is the result of independent individual research activities of an applicant of higher education, comprehensive study, which summarizes the study of his subjects, the curriculum for Bachelor degree 073 "Management", passing all practices.

Qualification is based on a deep study of special state and foreign literature, an actual experience of the subject and the results of applicants' own research of real object in order to address scientific and applied problems in future professional activity.

The list of qualifying works' themes is determined at the beginning of a year by graduating department. Subjects of a qualifying work must be directly related to the generalized subject of a professional of an appropriate educational level. The list of qualifying work themes is being approved by the rector prior to the pre-diploma practice. Students have the right to offer their own theme qualifying work.

Set of tasks for qualifying work should reflect all the industrial features and typical tasks of professional's activity and must be brought to the student in time (before pre-diploma practice).

The leaders of qualification works can be professors, associate professors of a graduating department, as well as leading specialists of a proper industry production sector.

Attestation of graduates of the educational program of Bachelor is carried out by an examination commission composed of representatives of employers and their associations, according to the provisions of the examination board, approved by the Academic Council of Rivne State Humanitarian University.

II. Certification

Student certification is carried out by Examining Board after training on educational level to determine the actual level of compliance with training requirements of the educational program. System of student's program learning results is imposed during certification which is defined in the educational program training. Form of certification: comprehensive state qualifying examination in the specialty, defense of a qualification work.

A comprehensive state examination in the specialty is performed as a complex professional knowledge test of future specialist's knowledge and skills, formation level of his professional competence. Certification program includes theoretical issues and practical complex tasks that correspond to a semantic module of program disciplines: "Management", "Marketing", "Economics of an Enterprise".

Program and form of state exam (verbal, written, test, combined, etc.), unique requirements for knowledge and skills (competencies) assessment of graduates, evaluation criteria are defined by a graduating department and lead to students no later than a semester prior to certification.

Qualifying work involves current issues, problems in the relevant field of knowledge analysis and theoretical development (design and research of processes and objects). The list of qualifying works' themes are defined by graduating department at the beginning of a year of study. Subjects of a qualifying work must be directly related to the generalized subject of a professional of an appropriate educational level. The list of qualifying work themes is being approved by the rector prior to the pre-diploma practice. Students have the right to offer their own theme qualifying work.

Set of tasks for qualifying work should reflect all the industrial features and typical tasks of professional's activity and must be brought to the student in time (before pre-diploma practice).

The leaders of qualification works can be professors, associate professors of a graduating department, as well as leading specialists of a proper industry production sector.

Attestation of graduates of the educational program of Bachelor is carried out by an examination commission composed of representatives of employers and their associations, according to the provisions of the examination board, approved by the Academic Council of Rivne State Humanitarian University.

Rivne State University of Humanities has a system for providing higher education establishment with quality education and higher education quality (internal quality assurance system), which provides for the following procedures and activities:

- 1) definition of principles and procedures for ensuring the quality of higher education;
 - 2) monitoring and periodic review of educational programs;
- 3) annual evaluation of higher education graduates, scientific, pedagogical and teaching staff of a higher educational establishment, and regular publications of such evaluations results on the official website of the higher educational establishment, on information billboards and in any other way;
- 4) providing a professional development of pedagogical, scientific and scientific and pedagogical workers;
- 5) providing the availability of the necessary resources for the educational process organization, including an independent work of applicants for higher education for each educational program;
- 6) providing the availability of information systems for an educational process effective management;
- 7) providing publicity of information about educational programs, degrees of higher education and qualifications;
- 8) providing an effective system of preventing and detecting academic plagiarism in scientific works of higher education staff and higher education graduates;
 - 9) other procedures and activities.

The system of providing a quality education and quality of higher education by higher education institution (system of internal quality assurance) may on the proposal of Rivne State University of Humanities be evaluated by the National Agency for Quality Assurance in Higher Education or accredited independent institutions evaluation and quality assurance for its compliance to requirements of quality assurance system for higher education approved by the National agency for quality assurance in higher education, and to international standards and guidelines for higher education quality assurance.
